**JIM HILTON**  
**1918 - 2005**

**J**im Hilton, who was one of the founding members of CALLERLAB in 1974, suffered a devastating fall in his home in August this year. He passed away in the hospital on August 8<sup>th</sup>. Jim was 87 and had maintained his membership in CALLERLAB until he retired in 1986.

Jim began calling in the 1950's using a second-hand sound system. The electronics training he received during his military service let him rework that system which led to a career as equipment supplier to the square dance world. His first commercial system was the model HP-95 and he continued to provide us with new and improved systems for several decades.

Jim's service to square dancing was recognized in 1982 with the award of the CALLERLAB Milestone. He and his wife Dottie lived in a retirement community where he had continued to research the design of audio speakers. He also called a few dances for the community. Jim will be long remembered and gratefully appreciated by all of us who carry equipment in and out of square dance halls around the world.

## PROGRAM POLICY CHANGE

### Basic Program

**T**he current CALLERLAB Program Policy is available on the CALLERLAB web site under "Dance Programs". A resolution to revise the Program Policy to add a dance program called "Basic" will be presented to the CALLERLAB Membership during the 2006 Annual CALLERLAB meeting on April 10, 2006. The resolution will be debated and voted on during the meeting. It will then be submitted by mail ballot to the entire CALLERLAB Voting Membership. If not overturned by the mail ballot, the results of the vote during the 2006 meeting will stand. This is a VERY IMPORTANT issue which should be of interest to ALL CALLERLAB Members. We encourage you to attend the 2006 CALLERLAB Convention and join the discussion of this item to voice your opinion.

## RESOLUTION SUBMISSION PROCEDURES

**T**he Board Of Governors has approved a process whereby proposals (resolutions) may be offered by any CALLERLAB Member (Active, Life, Associate, or Apprentice) to the membership for consideration, discussion, and vote. Such resolutions shall be in writing, signed by the maker and a second, each of whom shall be a Member (Active, Life, Associate, or Apprentice) in good standing of CALLERLAB. Resolutions shall be presented to the Executive Director in

writing either in person or by mail or fax to the Home Office. An explanation, in writing, of why the presenter feels the resolution is necessary shall accompany the resolution. The procedure requires resolutions to be submitted by January 1st of the Convention year so they may be listed in the "Call to Convention" and placed on the Convention agenda. Contact the Home Office for additional information.

## ELECTRONIC DIRECTION

**I**n the last issue of DIRECTION the Home Office asked if you would like to participate in our money saving effort by receiving DIRECTION through E-mail. We provided a self-addressed, stamped postcard for your use in furnishing your current information. We have had an overwhelming response to this request.

As of this publication of DIRECTION we have had 568 responses by post card and 31 who have responded by E-mail. Thanks to all of you who have responded and continue to support CALLERLAB

## DANCE PROGRAM TRIENNIAL REVIEW

**T**he CALLERLAB Program Policy requires a review of all CALLERLAB dance programs for content every three years. This review is conducted by each dance program committee and is known as the "Triennial Program Review." The review is conducted as follows: first the Mainstream Committee completes its review of the Mainstream Program, then the Plus Committee conducts its review of the Plus Program, then the Advanced Committee conducts its review, and finally the Challenge Committee conducts its review. During these reviews each program committee will review the applicable dance program to determine if any changes are required. Changes can include additions or removal of calls from the program. The committees may also decide that NO CHANGES are needed.

The Home Office would like to remind members that ALL members, including Associate Members, who have been calling over three years are eligible to be on committees and to vote on committee business. This includes this VERY IMPORTANT Triennial Review of the dance programs. If you are interested in the content of the dance programs, PLEASE join the program committee for the program(s) you call regularly. Please be aware that you must be calling the program of the committee you wish to join. Contact the Home Office to join any of the CALLERLAB committees.

## DANCE PROGRAM DEFINITIONS REVISION SCHEDULE

As you may have noticed, the dance program definitions have undergone several revisions in the past couple of years. Almost all of these changes have been for minor editorial, non-technical changes. We have reviewed our revision procedures and have determined that a regular schedule for such changes would provide much better service. Therefore, we have established a schedule for revision of the Dance Program definitions for non-technical changes. Significant technical changes will be incorporated and definitions revised as required. Scheduled revisions will be done, if required in June and December.

## PROGRAM POLICY INITIATIVE

A proposal to support experimentation with CALLERLAB Dance Programs named the *Program Policy Initiative* or PPI was introduced at the 2005 CALLERLAB Convention in Louisville, KY. The basic idea of the PPI is to encourage callers, clubs, associations, and others to conduct experiments of ways to get more people involved with square dancing. It must be stressed that these experiments are NOT intended to impact the current dancing community, they are intended to be a way to introduce square dancing to a large number of people. Some of these people MAY, at some future time, wish to join the activity as we know it today. The remainder of these people, it is hoped, will continue to enjoy the activity in a new way. Please read the following information carefully and if you have questions or concerns contact the CALLERLAB office (800-331-2577) or E-mail: CALLERLAB@aol.com. The following has been said of the PPI: My view of the PPI is that it is an attempt to discover and provide alternative ways for people to enjoy square dancing. It should not be viewed as a way of directly increasing membership in the existing clubs.

These experiments have NO limits. It is up to the imagination of those sponsoring the experiment to determine the extent of the experiment. This PPI is NOT intended as way to provide legitimacy to any existing so-called one floor programs. It is, however, intended to encourage different ways to introduce square dancing to more non-dancers.

CALLERLAB members have been expected to teach and call according to a series of dance programs, which were codified in the 1970's. These dance programs which have been excepted world wide programs include Mainstream, Plus, Advanced, and the various Challenge programs. We are aware that our efficiency at recruiting new dancers into Mainstream has fallen sharply over the last 10 to 15 years. Individually and collectively we have tried to increase attendance in our classes and clubs. There have been some successes in changing how we teach Mainstream, for example,

multi-cycle classes. Many of these successes have been documented as Winning Ways and are available on our web site. You are encouraged to take the time to read and get inspired by these reports. Surveys and study groups indicate that few are willing to join an activity which requires such a long commitment (say 15 to 30 weeks) just to learn to be an entry-level dancer. After that we hope they will sign up for what amounts to a lifetime commitment, including becoming club members and, later club officers.

Instead of getting upset with our existing dancers and our existing rules and regulations, you are invited to start with some new dancers, teach them your way, and don't take them all the way to Mainstream. Try an experimental program with a new set of dancers and keep them having fun, then report your success or failure to the CALLERLAB Office. As a caller you have the skills. You can do it. Please let us know what you are trying as a way to increase the number of dancers.

CALLERLAB is an International organization and the American square dance has been introduced to thousands of people outside the North American Continent. These people have had the opportunity to experience an American folk dance because callers all over the world have adopted the standards developed and made available to them by CALLERLAB.

The membership of CALLERLAB has agreed that attendance at a CALLERLAB convention is an important experience. Attending a convention contributes to a sense of belonging and an improved understanding of the goals and policies of the organization. The Board Of Governors has established a policy that "Mini-Labs" which are mini-CALLERLAB Conventions may be sponsored and hosted by CALLERLAB Affiliated Associations. The membership of CALLERLAB supports attendance at a CALLERLAB convention or Mini-Lab as

a way to meet the requirements of "Active" Membership. The requirement to attend a convention in North America places a significant financial burden on callers residing outside this area. Mini-Labs are intended to reduce this financial burden and to provide callers living outside North America an opportunity to participate in the experience of a gathering supported by CALLERLAB and attended by representatives of the leadership of the organization.

Mini-Labs may also be sponsored within North America with the goal of making the convention experience available at a reduced cost due to the reduction in the program and services provided.

The guidelines for requesting, sponsoring, and running a Mini-Lab have been updated and are available through the CALLERLAB office. Requests for copies of the updated guidelines may be sent by regular mail, E-mail, Fax, or phone. Please contact the Home Office for more information.

## CALLERLAB and The ARTS

**C**ALLERLAB has joined with other associated dance organizations to form an alliance of related dance groups with the goal of improving our activity and increasing the number of square dancers. This alliance has been named: The Alliance for Round, Traditional, and Square (ARTS) Dance. The ARTS is a tax-exempt IRS 501 (c)(3) corporation based in North Carolina with a full slate of dedicated officers. This organization, like many other alliances is a gathering of different independent organizations for the purpose of achieving common goals. The independent organizations retain their individual identity, character, mission, and goals while supporting the common goals of the alliance. In this case that goal, as stated in the Goals and Mission Statement of The ARTS, is:

The **ARTS** mission is to generate public awareness and promote growth and acceptance of contemporary Square, Round, and Traditional Folk Dance by encouraging and assisting a coalition of allied dance groups. The ARTS will provide leadership and resources necessary to create an achievable marketing program. The Arts will encourage, promote and support healthy lifestyles through dance programs and events that provide fun and effective exercise for both mind and body, all within a unique system of social interactions

During a recent meeting in Orlando, FL, The ARTS met and discussed several issues including: 1) A toll-free telephone number, 1-866-445-ARTS(2787), is now up and running for the public to access current information on Round, Traditional and Square dancing nationwide. It provides contact information useful to potential new dancers and also to current dancers looking for dance locations in areas where they are traveling; 2) A demographic survey of dancers was developed and conducted at the National Square Dance in Denver, CO, in 2004, and Portland, OR this past summer, and will be repeated in Charlotte, NC in 2007. These contain vital information needed when we approach companies and

organizations for sponsorships and grants; 3) The ARTS issued its first grant in the amount of \$1,000 to the California Square Dance Council, Inc., for its *Teach the Teacher* program, an educational package for helping get square dancing into schools. This program can serve as a pilot program for use in other states; 4) A grant request for funding of a program to implement dancing as a way to combat youth obesity; and 5) A Nation Wide Day of Dance to help publicize our dance activity to increase awareness of the activity and raise funds for The ARTS.

The establishment of The ARTS is a major milestone in *The Phoenix Plan*, the long range three phase marketing plan approved and implemented by the CALLERLAB Foundation. While there has been much progress and many accomplishments in establishing The ARTS, there is much work to do.
