## CALL TO CONVENTION

**I**n accordance with the By-Laws, notice is hereby given of the Call to Convention to be held at the Renaissance Suites Hotel, Charlotte, NC on April 10-12, 2006. All Members, Life Members (Gold Card Holders), Associate Members, and Apprentice Members are cordially invited to attend. Convention invitations and registration packets were included in the November issue of *DIRECTION*. The By-laws provide the following concerning matters to be voted on at the annual meeting: **Section 4. Quorum.** The quorum for any meeting of the members shall be a majority of the Voting Members present at such meeting. However, if less than one-third of the corporation's Voting Members actually attend the meeting, then the only matters that may be voted upon are those which were described generally in the notice of the meeting. The Voting Members present at a duly held meeting at which a quorum is present may continue to do business until adjournment, notwithstanding the withdrawal of enough members to leave less than a quorum.

A motion to revise the CALLERLAB Program Policy will be presented, debated, and voted on during the 2006 CALLERLAB Annual Membership meeting. The meeting will be held at 9:00AM, Wednesday, April 12, 2006 in the Renaissance Suites Hotel in Charlotte, NC.

The motion proposes to revise the CALLERLAB Program Policy by adding a dance program called Basic. The proposal calls for this Basic Program to consist of the first 53 Calls on the Mainstream Program at the time the motion is approved.

## MOTION TO REVISE THE PROGRAM POLICY

**A** motion to revise the CALLERLAB Program Policy will be presented, debated, and voted on during the 2006 CALLERLAB Annual Membership meeting. The meeting will be held at 9:00AM, Wednesday, April 12, 2006 in the Renaissance Suites Hotel in Charlotte, NC. The motion proposes to revise the CALLERLAB Program Policy by adding a dance program

called Basic. The proposal calls for this Basic Program to consist of the first 53 Calls on the Mainstream Program at the time the motion is approved.

The following statements, one for and one against the Motion are provided for your consideration as you review the Motion and what you believe the result of the vote on this Motion should be.

The members present at the 2006 Annual CALLERLAB business meeting will vote on this Motion. It will then be submitted to all Voting Members by regular mail for a vote. If the vote by the Voting Members during the mail ballot does not overturn the vote at the Annual Business Meeting, the vote taken at the meeting will stand.

### PRO (FOR) STATEMENT

**T**he following is a Pro Statement speaking FOR the Motion to Revise the CALLERLAB Program Policy to create a dance program called Basic:

In an attempt to provide our members with both sides of this important issue, the following is submitted in favor of returning the Basic Program to CALLERLAB's list of programs.

When CALLERLAB voted to eliminate the Basic Program it caused a language problem in Europe. Since then attempts have been made to identify that group of calls with the term Mainstream 53. This has caused problems. Callers and dancers throughout Europe have proposed to reinstate the term Basic for their own use. We fear that this could lead to various locally defined programs thus defeating the world-wide acceptance of CALLERLAB programs.

A further reason for reinstating the Basic Program is the hope that active support from a committee would encourage use of the program. The square dance community has changed considerably since the program was eliminated. We are now more aware of a need to make available a less demanding form of square dancing if we hope to increase recruitment. While there is no assurance that Basic is the "correct" program, it is one with a long history that is widely known. This motion would return responsibility for the program to the

Mainstream Committee. It is our hope and expectation that changed attitudes would encourage expanded use.

Some have suggested that restoring this program would discourage experimentation with other approaches that are being encouraged under the Program Policy Initiative (PPI). We believe that the development of alternative approaches will continue whether or not Basic is restored. Such experimentation is underway primarily in areas where Basic has had no support in the past. Restoring the program for use by those who have used it in the past will have no impact on groups, callers or areas seeking alternative ways of introducing square dancing.

### CON (AGAINST) STATEMENT

**T**he following is a Con Statement speaking AGAINST the Motion to Revise the CALLERLAB Program Policy to create a dance program called Basic:

In 2000, the CALLERLAB membership voted overwhelmingly in favor of the Program Policy. In doing so they realized that the entry program for Modern Western Square Dancing would be Mainstream and as a result, the term Basic would be dropped. Many believed at that time that the ultimate result would be a reduction in the size of the Mainstream program making it more attractive to today's busy people. To reinstate the term Basic now would be a mistake and would do absolutely nothing to solve the problems that are facing Modern Western Square Dancing today. Compared to the overall number of MWSD clubs, there were virtually no Basic clubs in existence before the term was dropped. Out of those very few clubs, none ceased dancing because the term no longer existed. The Basic program was not a preferred program before and there is no evidence that it will become a preferred program now. It is not going to make a major difference in our activity therefore we should not be reinstating now. Using the term "MS 1-53" will work and has worked in place of the term Basic. Dances and festivals used to advertise dances as Basic or some subset of Basic such as, Basic 1-25 or Basic 1-33. Now they are advertising dances as MS 1-53 or MS 1-25 and MS 1-33. In the overseas area, the reason given that Basic should be re-

stored is based on the language problem. That in countries where English is not the native language it is easier to understand the term Basic but it is hard to understand the term MS 1-53. Yet when Basic was still a term these same countries would advertise dances and festivals as Basic 1-25 or Basic 1-33 depending on where their current dance classes were in order to accommodate them. Why is Basic 1-33 easy to understand and MS 1-53 hard to understand? It doesn't make any sense. A few places throughout the world have gone against CALLERLAB recommendations and reinstated the term Basic. They have used the Program Policy Initiative (PPI) as their reasoning for doing this. The PPI encourages experiments. The PPI wants the results of these experiments reported so that all can make more informed decisions. Currently there are many of these experiments going on throughout the world. Things such as different ways to conduct classes and the learning experience. Different teaching orders for the Mainstream program, different calls and teaching orders for the current MS 1-53 list. All of these are examples of different ways of thinking. Out of all these experiments we could be able construct a dance program that is marketable and attractive to today's prospective new dancer. Reinstating the term Basic simply to reinstate a name does not represent an experiment. It is simply a return to a way and program that has already proven that it does not work and is not wanted. Reinstating Basic is the wrong move.

### FROM THE CHAIR

**T**his is my last chance to write to you as Chairman. At the conclusion of the Wednesday morning meeting of the convention, my term as your Chairman will end. Often in this final note to you, one would reflect on the past, but I'd rather give you my wish list and take a look forward.

These past two years as your Chairman have been rewarding, frustrating, eye opening, grueling, and fun, all at the same time. I experienced politics at its peak and I watched sectors of this organization accomplish an amazing amount of work.

It's true that everyone in this organization has the best intentions for the future of square dancing; it's our ideas about how to reach that common goal that differ. That difference of opinion leads to, at times, a painful pace for some, and a sense of comfort for others who find discomfort in the idea of change. Validating and legitimizing those varied ideas of how to reach that common goal has been my consistent message, and is my biggest wish!

I continue to send the same message that I have for two years. I wish those of you who have had success and those of you who have tried and failed, would volunteer your story to the Program Policy Committee so we can learn, and perhaps find, a way to guarantee the future

of square dancing. We have a procedure to hear and monitor your experiments the *Program Policy Initiative*. I believe that encouraging experimentation can lead to a solution for square dancing in the same way that companies test market products before they change their existing product. Seldom does a company hit the market with a changed product before testing it....that is all I ask: that whatever we do, we have data to support it.

In the midst of all the politics, the strong feelings, and the perceived complacency, the common thread of a desire to find a way to guarantee the future of square dancing is there. It will be this organization that leads the way, I'm sure of it, and I believe it will be found out there on the floor, not in the Boardroom of CALLERLAB. CALLERLAB'S roll will be to manage the findings, and formulate an effective delivery tool, and management of the ongoing evolution of the programs, whatever they eventually become. I hope we do just that....lead the way.

My final parting words are simple. Support that common thread of a prosperous future however you feel you need to. Be a member of CALLERLAB, and get on a committee. Be heard. Speak your piece. Be part of the solution, not part of the problem. Don't give up...it's in our hands!

Thank you for the support you've shown me over the years, but more importantly, thanks for supporting the greatest organization of Callers in the world; CALLERLAB.

If you live in the USA, you will also need to pay your insurance and BMI/ASCAP fees. **On April 1, 2006, a \$10.00 late fee will be added to the dues for a total of \$105.00 in addition to any insurance or license fees.**

### **2006 DANCE PROGRAM TRIENNIAL REVIEW**

**T**he CALLERLAB Program Policy requires a review of all CALLERLAB dance programs for content every three years. This review is conducted by each applicable dance program committee and is known as the "Triennial Program Review." This review is conducted as follows: first the Mainstream Committee completes its review of the Mainstream Program, then the Plus Committee conducts its review of the Plus Program, then the Advanced Committee conducts its review, and finally the Challenge Committee conducts its review. During these reviews each program committee will review the applicable dance program to determine if any changes are required. Changes can include additions or removal of calls from the program. The committees may also decide that NO CHANGES are needed. A review of the initial work on the 2006 Program Reviews will be done at the 2006 CALLERLAB Convention in Charlotte, NC April 10-12, 2006.

The Home Office would like to remind members that ALL members, including Associate Members, who have been calling over three years are eligible to be on committees and to vote on committee business. This includes this VERY IMPORTANT Triennial Review of the dance programs. If you are interested in the content of the dance programs, PLEASE join the program committee for the program(s) you call regularly. Please be aware that you must be calling the program you wish to join. Contact the Home Office to join any of the CALLERLAB committees.

### **25 YEAR CERTIFICATES**

**A**re you eligible for a 25 Year certificate in 2006? We would like to let all members know the policy and procedure in place concerning this very important and historic milestone in any caller's career. The following is the policy for presenting the 25 Year Certificates: 1) During the CALLERLAB convention the 25 Year Certificate will be presented to each member who be-

comes eligible during that year and is attending the convention, 2) Certificates will be mailed to the members who become eligible in that year but do not attend the convention, and 3) members who became eligible in previous years and are attending the convention will be acknowledged. If you believe you are eligible this year (started calling in 1980) please contact the Home Office to confirm we have the correct information in our files.



Applications for the 2006 CALLERLAB and CALLERLAB Foundation scholarships, must be received by the Home Office no later than May 1, 2006, in order to be considered by the Executive Committee at their Spring 2006 meeting.

CALLERLAB also sponsors an association grants program. The intent of this program is to help make quality caller training available to caller associations that are affiliated with CALLERLAB and could not otherwise afford it.

CALLERLAB Affiliated Callers Associations may apply for a grant of up to \$150 a day, to a maximum of \$450, under this program, providing they are able to establish that the intended program could not be held without some form of financial assistance and that it has received no CALLERLAB training grant for a period of at least three years prior to the date of the proposed clinic or training program.

To qualify for a grant, the association must submit a written application at least four months prior to the date of the intended program.

## "BLAST" PLUS SESSION

(January 2006)

**W**e received the following information from **Mike Callahan**, a CALLERLAB Member from Spencerport, NY. This report provides information about "BLAST Plus" Sessions. A "BLITZ" or "BLAST" Session is a very concentrated introduction of a specified set of calls, in this case calls from the CALLERLAB Plus Programs were covered.

### BLITZ Report -

On Saturday afternoon, January 21, 2006 myself and two other area callers, Ron Brown and Jerry Carmen, ran a "Blast" Plus workshop. The pre-requisite for attendance was that the dancers should have been through a Plus workshop or at least familiar with some of the Plus calls. We also advertised it as a workshop for those who didn't feel confident dancing the Plus Program. The program ran from Noon to 5 P.M. and admission was \$25.00/couple. We explained to the dancers who attended that we were teaching/walking through, work shopping, and reviewing as many Plus calls as we could from only the most common positions that they might hear the calls at an open dance. We programmed 3 tips per hour alternating the 3 callers with no singing calls. We were able to get through the entire Plus program in 5 hours and 15 minutes.

We are happy to report that we had almost 8 squares in attendance. We felt that this was a great success because we actually only advertised the workshop for about 2 months. The dancers who attended had a super time and raved about it. It was amazing to see that almost every dancer there danced almost every tip. We are actually thinking now of not only doing this again next year but also having a "Mainstream Blast" for new graduates perhaps in early next September.

### SUCCESS WITH MS 1 - 35

**T**his report provides information about a club in Germany and their caller Heiner Fischle. The

club has reportedly been successful using the first 35 calls on the CALLERLAB dance program lists. This information is provided as a source for a different idea about square dancing and destination points.

Heiner writes: In June 2004 I was asked to start a new SD group at Hameln/Weser (of Pied Piper fame). I promised we could attend the next Student Party (= MS 35), and we made good on this. In December 2004, we danced Basic 35 pretty well.

Then in February/March 2005, some new members dropped in, one or two every fortnight. At first I tried to combine teaching "basic Basics" with teaching Ocean Waves; but soon I dropped back to something like the ABC method. (I learned about the ABC method only some months later; however it is the strategy I use at Open Country Hannover since years.) In May, we had 18 members, and we could dance Basic 35 again. Then we dived into the Ocean Waves. November 2005 we are up to Basic 53, and down to 10 active members. 3 were left behind due to illness/rehabilitation. 2 of the new members found a job which prevented them from attending. 2 charter members said, they never intended to take square dancing that seriously. (One of them had suggested our name in September 2004.) Of the last missing one, I have no data.

Some of the active members asked to slow down the learning rate. So we decided to stay for a while within Basic 53. It helped to reach that decision that there are some events where you can dance this program, e.g. the ECTA Student Jamboree, Pentecost Monday at Hamburg, Hall 7 at the European SD Convention. (Don't worry about the terrible fire at Hemel-Hempstead; it will not affect this event.) But in February, latest in March we will tackle the final dozen of MS Calls.

So these are my conclusions:- You can run a Basic 35 group for years. (Open Country Hannover started in September 1986)- Basic 53 is helpful, sometimes, for a while (but not as a destination program) - Basic 36 ... 53 is the area where attrition sets in.



### *Before the Dance - 2004*

Presenter Bob Riggs - This DVD is one of the presentations during the BDPLS held immediately prior to the 2004 CALLERLAB Convention. There are many "behind the scenes" activities and plans required before we actually call a Beginner Dance Party. This session features one of the leaders in the field of beginner parties to illustrate how to prepare for the dance. This DVD includes five sections: 1) Beginning - An introduction of the session includes information about how to prepare for the dance, topics covered include various types of parties; 2) Dances Needed - Information about various types of dances available for the parties, suggestions for planning dances and the importance of being flexible; 3) Telephone Skit - A scripted skit to simulate a typical telephone exchange, from initial contact to final agreement; 4) Back To Bob - Follow-up to the Telephone Skit, more information about how to prepare and gather information about the dance; 5) Comments - Input from the audience, includes comments and personal experiences.

### *Dancing Outside the Box and Beginner Dance Mixers - 2004*

Presenter Calvin Campbell - This DVD is one of four presentations during the BDPLS held immediately prior to the 2004 CALLERLAB Convention. There are many different types of dances which can add to the variety of the dance, entertainment, and fun of a Beginner Dance Party. Some of these dance forms are not part of the program we find at a typical Modern Western Square Dance. Learning and using these dance forms can add to a caller's ability to entertain dancers who attend Beginner Dance Parties. This session features one of the leaders in the field of beginner parties to introduce many of these dances. This DVD includes two sections: 1) Dancing Outside The Box - Includes an introduction of the following dances: No Name Contra, Tunnel Contra, Thiel's Trio, TBC Trio, Sicilian Circle, Siege of Carrick, ONS Mescolanza, and Dumbarton Drums; and 2) Beginner Dance Party Mixers - Includes an introduction of: the following Mixers: I Don't Know Why, Light In The Window, C.J. Mixer, and Kiwi Ring.

Father/Daughter Dance - 2004

Presenter Gerry Hardy - This DVD is one of four presentations during the BDPLS held immediately prior to the 2004 CALLERLAB Convention. A Father/Daughter Dance is a common type of Beginner Dance Party. Most active callers possess the basic skills needed for this type dance . This session features one of the leaders in the field of beginner parties to show how those skills can be used to teach various dance formations and dances. This DVD includes nine sections: 1) Beginning - An introduction of how to begin the dance; 2) Big Circle - Shows how to dance in a Big Circle and how to teach various calls; 3) Sicilian Circle - Introduces this formation of two facing couples arranged in a big circle; 4) Squares - Transition from Sicilian Circle to squares; 5) Singing Calls - Introduces the use of singing calls; 6) Alabama Gal - Introduces a dance with all daughters; 7) More Squares - More dancing in squares using calls previously introduced; 8) Soloman Levi - Introduces this dance in squares; and 9) Barnacle Bill - Introduces this dance in squares, includes introduction of "Change Over".

Handicapable Dancing - 2004

Presenter Michelle Jacobs - This DVD is one of four presentations during the BDPLS held immediately prior to the 2004 CALLERLAB Convention. Calling for Handicapable Dancers requires certain skills and perceptions which can be studied and learned. This session covers those skills by one of the leaders in the field. This DVD includes six sections: 1) Start - An introduction to the session; 2) The Square - Introduces disability awareness with a description of various disabilities; dancers are given props to simulate these disabilities; 3) Calling - Sample calling to the dancers who are simulating different disabilities; 4) Dancing - continuation of sample square dance calling and dancing; 5) Marketing - How To Start - information about how to start a handicapable group and where to find more information about handicapable dancing; and 6) Other Dances - Information about other dance forms which can be used with Handicapable Dancers.

History - Heritage - Tradition - 2004

Moderator, Jim Mayo and Panelists, Herb Egender and Jon Jones - This has been one of the most popular sessions at several CALLERLAB conventions. Our History, Heritage, and Tradition are very important aspects of our activity. This information is sometimes overlooked as we deal with the "puzzle" aspects of modern day choreography. This panel is well qualified to provide information about our past and the rich heritage of square dancing and calling.



## Memorial Tree Dedication Service To Carl and Varene Anderson Thursday, June 22, 2006

The National Executive Committee of the National Square Dance Convention® began a living memorial to the founders of the National Square Dance Convention® in Riverside, California in 1952. Carl and Varene Anderson, the first General Chairman, are both deceased. Their dream will live on with each national convention.

A tradition was started in Oklahoma City, Oklahoma on June 26, 2003 with the planting and dedication of a tree in their honor.

On Thursday, June 22, 2006 at 10:00 am, this tradition will continue with the 55<sup>th</sup> National Square Dance Convention®. The dedication of a Monterrey oak tree, which was planted in February 2005, a few feet from the sidewalk on the West side of the Dancing Fountains, will be presented by the National Executive Committee. The location of the oak tree will allow dancers to view it for many years. You will want to include this Tree Dedication Service in your convention activities, Thursday, June 22, 2006 at 10:00 am.

## For the Aviation Enthusiast

Aviation enthusiasts will find San Antonio a real treasure. Lackland Air Force Base has a very large number of static displayed aircraft. If you find yourself on I-10 exit the Lackland AFB ramp. Head south through the main gate and you will soon see off to your left a park dedicated to old Air Force aircraft. They are arranged in a circle with name plates and descriptions. This park has a lot of aircraft on display, but Lackland has aircraft on display all over the base. On your way back out you will notice to the south a SR-71 Blackbird and a F-4 Phantom on a side road. If you follow this road a little way you will find yourself approaching Kelly Field. As you pass the Texas National Air Guard ramp you might catch site of a C-99, it was the cargo version of the B-36. While on Kelly notice the huge hangers on east Kelly they are big enough to swallow C-5 Galaxies. You can find a B-58 Hustler on display at the east Kelly gate.

Another aviation museum will be on Fort Sam Houston. The U.S. Army bought its first airplane after acceptance trials at Fort Myers, Virginia on August 2, 1909. It was a Wright aircraft designated Flyer 3. Two months later the aircraft was sent to College Park, Maryland where two officers were selected for pilot training. After the pilots were rated they were soon reassigned to other duties. Lieutenant Benjamin Delabauf Foulois was then selected to fill the aviator gap. Foulois flew with Orville Wright during the acceptance trials, but was not trained to fly. He was told to pack up the aircraft and move to Fort Sam Houston. Foulois arrived in San Antonio on February 5, 1910, with eight men, his 17 crates with Flyer 3 in them and \$150.00 for the first year operation expenses.

The Fort Sam Houston Museum has the Birth of Military Aviation display that describes the early days of the Air Force.
