## FROM THE CHAIR Tim Marriner, Chairman

**N**orman Rockwell's art work often depicts the simple pleasures of life that go unnoticed. Images of small town dreams and hometown goodness were captured reflecting wholesome family values, respect, freedom, pride and honor. Square Dancing has a heritage with roots embedded in a similar foundation. Years ago hard working folks would unite as a team to accomplish a chore for someone in need. Afterwards, as an offering of thanks, families would gather for food and dance. Anyone who could play a musical instrument brought it along and those who could lead others assisted with the dances. Even today square dancing appeals to people who embrace similar qualities of life.

I am not advocating we go back to the barn days of dancing, merely suggesting we often forget the simple values our activity provides. In fact, some shy away from this image claiming it to be old fashion and not hip with current marketing trends. Say the words square dance to a non dancer and laugh at their reaction; "Yee haw, swing y'er partner!"

But you know what, hoedowns **are** fun! Book a party dance and who cares how many hay bales and bannanas show up, folks came to have an old fashioned good time. Maybe we should capture this feeling of fun and fellowship at all our dances instead of trying to over sophisticate our folk art.

Remember when you were introduced to Modern Western Square Dancing? Usually, it was at this type of party dance event. No experience was required and plenty of smiles and laughter were had by all. Bottom line, you loved it! If we could only capture this excitement and introduce it to everyone, plenty of folks would have the proper image of our activity.

The late **Bob Osgood** made his thoughts clear during his last Board of Governors informal. In his opinion we focused our attention too much on the puzzle, losing sight of our activity's social side. Think about that! Dancers used to do things other than dance. Picnics, camping, cook outs, pool parties, ice cream socials, karaoke sing-a-longs, dinner parties, community theater, and charitable events occurred regu-

Will you be eligible for a 25 or 50 Year Certificate in 2007? We would like to let all members know the policy and procedure regarding this very important and historic milestone in any caller's career. The following is the policy: 1) During the CALLERLAB convention the 25 and 50 Year Certificate will be presented to each member who becomes eligible during that year and is attending the convention, 2) Certificates will be mailed to the members who become eligible in that year but do not attend the convention, and 3) Members who became eligible in previous years and are attending the convention will be acknowledged. ### ADVANCED AND CHALLENGE (C-1 and C-2) 2006 TRIENNIAL REVIEW COMPLETE

The CALLERLAB Program Policy requires a review of all CALLERLAB dance programs at least once every three years. This review is conducted by each applicable dance program committee and is known as the Triennial Program Review. This review is conducted as follows: first the Mainstream Committee completes its review of the Basic & Mainstream Programs, then the Plus Committee conducts its review of the Plus Program, then the Advanced Committee conducts its review, and finally the Challenge Committee conducts its review. During these reviews each program committee will review the applicable dance program to determine if any changes are required. Changes can include additions or removal of calls from the program.

The **Mainstream and Plus Committees** have completed the review of their programs. The results of these reviews were published in the September/October issue of *DIRECTION*.

The **Advanced Committee** has completed the review of the Advanced (A-1 and A-2) Program. The results of that review are that there are NO CHANGES to the Advanced Program.

The **Challenge Committee** has completed the review of the Challenge C-1 Program and the Challenge C-2 Program. The results are that there are NO CHANGES to the C-1 Program nor to the C-2 Program. 2006 Review of the C-3A Program has begun.

### DEFINITIONS REVISED

We are pleased to announce the Mainstream, Plus, and Advanced, dance program definitions have been revised and posted on the CALLERLAB website. There is ongoing work to review and make further revisions to the Mainstream definitions and the C-1 definitions. The published revised definitions reflect the results of the 2006 Dance Program Reviews and other work completed by the dance committees. ## FORMATION AND ARRANGEMENTS CHART

**D**ottie Welch, Chairman of the Choreographic Applications Committee, announces the completion of a long term project to update the Formation & Arrangement (F&A) chart. The F&A chart provides a technical visual display of the Arrangements (Boy-Girl Positions) for 27 selected Formations. CALLERLAB has identified over 50 Formations which can be created through the application of modern square dance choreography. Of these over 50 Formations, 27 have been selected for further analysis and study to determine the six possible Boy-Girl Arrangements for each. This task has involved the work of countless CALLERLAB Members who have provided their expertise, assistance, and guidance to the completion of this project. ## NEW PASSPORT RULE

## NEW PASSPORT REQUIREMENTS

*Under the Western Hemisphere Travel Initiative (WHTI)*

**Copied from the US Department of State**

**T**he proposed implementation timeline has two phases:

On **January 8, 2007**, ALL persons, including U.S. citizens, traveling by **air** between the United States and Canada, Mexico, Central and South America, the Caribbean, and Bermuda will be required to present a valid passport, Air NEXUS card, or U.S. Coast Guard Merchant Mariner Document.

As early as **January 1, 2008**, ALL persons, including U.S. citizens, traveling between the U.S. and Canada, Mexico, Central and South America, the Caribbean, and Bermuda by **land** or **sea** (including ferries), may be required to present a valid passport or other documents as determined by the Department of Homeland Security. While recent legislative changes permit a later deadline, the Departments of State and Homeland Security are working to meet

all requirements as soon as possible. Ample advance notice will be provided to enable the public to obtain passports or passport cards for land/sea entries.

#### **Travel Documents for U.S. Citizens Under WHTI**

Under the proposed implementation plan, the following documents will be acceptable to fulfill document requirements:

**U.S. Passport:** U.S. citizens may present a valid U.S. passport when traveling via air between the United States and Canada, Mexico, Central and South America, the Caribbean, and Bermuda, and may also use a U.S. passport when traveling via sea and land borders (including ferry crossings).

**The Passport Card** (also referred to as the PASS Card): This limited-use passport in card format is currently under development and will be available for use for travel only via land or sea (including ferries) between the U.S. and Canada, Mexico, the Caribbean, and Bermuda. Similar in size to a credit card, it will fit easily into a wallet.

DOS and DHS also anticipate that the following documents will continue to be acceptable for their current travel uses under WHTI: SENTRI, NEXUS, FAST, and the U.S. Coast Guard Merchant Mariner Document. As proposed, members of the U.S. Armed Forces on active duty traveling on orders will continue to be exempt from the passport requirement.

#### **Background**

The Intelligence Reform and Terrorism Prevention Act of 2004 requires the Department of Homeland Security and Department of State to develop and implement a plan to require all travelers, U.S. citizens and foreign nationals alike, to present a passport or other document, or a combination of documents, that denote identity and citizenship when entering the United States. Congress amended portions of the Act in 2006. The Western Hemisphere Travel Initiative is the Administration's proposed plan to implement this mandate.

The goal of the Initiative is to strengthen border security and facilitate entry into the United States for U.S. citizens and legitimate foreign visitors by providing standardized, secure and reliable documentation which will allow the Department of Homeland Security to quickly, reliably and accurately identify a traveler.

## **2007 IRS MILEAGE RATE**

**A**s of Jan. 1 2007, the Internal Revenue Service's suggested mileage rate for using a car for business travel will increase from 44.5 cents per mile to 48.5 cents per mile. Companies are free to set their own rates, according to the IRS; the rate merely is a guide based on an annual study of the cost of operating an automobile. We are providing this data only as information. Please consult a tax specialist to determine how this information applies to you.

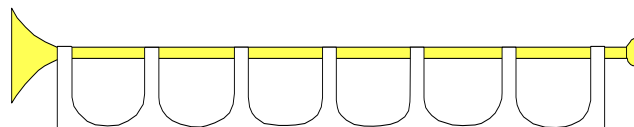

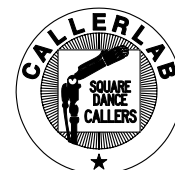

# David Krediet Scholarship Fund

(Revised November 6, 2006)



## Purpose of Fund:

In accordance with the heart of David Krediet and the wishes of his family, proceeds from this scholarship fund will be used exclusively for disbursement to callers on a scholarship award basis.

## Fund Disbursements:

Scholarships shall be awarded based on the following priorities: Calling experience, previous training, need, and intentions. This fund shall be administered by the CALLERLAB Foundation Executive Directors (FED).

In David's short calling career, he came to recognize the need that he and other new callers have to gain the experience of structured caller training through attendance at a caller school. Therefore, priority in award selection shall be given to newer callers who have not yet attended a caller school, or who have been calling less than five years at the time of application. However, this is not meant to limit applicants only to those who have been calling less than five years. Any caller, or aspiring caller can apply. In the event that no newer callers have applied, an experienced caller can receive an award after consideration of all other factors listed above.

No single award shall exceed 75% of the combined cost of tuition and room and board, if room and board are a normal part of the cost of the school and only if the participant takes advantage of the room and board. Otherwise, no single award shall exceed 75% of the tuition cost. No award shall exceed \$200.

In the event that a husband/wife or other "team" of callers, both of whom are paying for the caller school, should apply, any award given the "team" shall not exceed \$400 in total. The award shall not exceed 75% of combined tuition cost, and room and board cost, if applicable.

The school to be attended must include at least one CALLERLAB Accredited Caller-Coach on the staff and the school must offer the full 40 hour CALLERLAB Caller School Curriculum.

Applicants must complete the enclosed application form in its present or later amended form. Applications will be accepted at the CALLERLAB Home Office until May 1<sup>st</sup> of each award year. All applications received by May 1<sup>st</sup> will be considered by the CALLERLAB Foundation Executive Directors (FED). Applications received after May 1<sup>st</sup> may not be considered. Each applicant must submit a written essay. This essay must include: 1) brief history of dancing & calling experience, 2) history of past caller training, including list of schools, 3) statement of need: 4) and a statement of intention. Those callers who have been calling less than five years and have not yet attended a caller school shall be given priority in the selection process.

No single individual shall receive more than one scholarship award from this Fund. No husband/wife or other "team" shall receive more than one scholarship award from this Fund, considered jointly or severally. Approval of an application by a caller or "team" who has received another scholarship through CALLERLAB or the CALLERLAB Foundation will not normally be approved except for exceptional circumstances as determined by the FED.

The CALLERLAB Foundation Executive Directors shall review each application and may award additional grants as deemed appropriate by the circumstances of the application.

### Purpose of Fund:

In compliance with the wishes and objectives of Grand Square Inc (GSI), proceeds from the Fund are intended for use by:

- 1) A deserving dancer who has indicated a desire to learn how to better serve square dancing,

Grants shall be awarded based on the following priorities: need, existing skills, training, intentions, and educational aspects of the event/school.

For an individual application, no single award shall exceed 75% of the combined cost of tuition and room and board, if room and board are a normal part of the cost of the school and only if the participant takes advantage of the room and board. Otherwise, no single award shall exceed 75% of the tuition cost, and awards will normally NOT exceed \$200.

In the event that a husband/wife or other "team" should apply, both of whom are paying for the caller school, any award given the "team" shall not exceed \$400 in total. The award shall not exceed 75% of combined tuition costs, and room and board costs if applicable.

If an organization should apply, any award given the organization shall normally not exceed \$500. The award shall not exceed 75% of the total cost of the event.

Applicants must complete the enclosed application form in its present or later amended form. Applications will be accepted at the CALLERLAB Foundation Office until May 1st of each award year. All applications received by May 1st will be considered by the CALLERLAB Foundation Executive Directors (FED). The application requires a statement of intention. Each applicant must complete the statement of intention.

No single individual shall receive more than one grant from this Fund. No husband/wife or other "team" shall receive more than one grant award from this Fund, considered jointly or severally. Normally an organization shall not receive more than one grant from this Fund. Approval of an application by a caller or "team" or organization which has received another scholarship through CALLERLAB or the CALLERLAB Foundation will not normally be approved except for exceptional circumstances as determined by the FED.

The CALLERLAB Foundation Executive Directors shall review each application and may award additional grants as deemed appropriate by the circumstances of the application.

## Bill Helms Memorial Scholarship Fund

(Revised November 6, 2006)



### Purpose of Fund:

In compliance with the wishes and objectives of Bill Helms, proceeds from this scholarship fund will be used exclusively for disbursement to callers on a scholarship award basis.

### Fund Disbursements:

Scholarships shall be awarded based on the following priorities: Calling experience, previous training, need, and intentions.

In his lifetime Bill Helms was concerned that newer callers gain the experience of structured caller training through attendance at the caller school. Therefore, priority in award selection shall be given to newer callers who have not yet attended a caller school, or who have been calling less than five years at the time of application. However, this is not meant to limit applicants only to those who have been calling less than five years. Any caller, or aspiring caller can apply. In the event that no newer callers have applied, an experienced caller can receive an award after consideration of all other factors listed above.

No single award shall exceed 75% of the combined cost of tuition and room and board, if room and board are a normal part of the cost of the school and only if the participant takes advantage of the room and board. Otherwise, no single award shall exceed 75% of the tuition cost. No award shall exceed \$200.

In the event that a husband/wife or other "team" of callers, both of whom are paying for the caller school, should apply, any award given the "team" shall not exceed \$400 in total. The award shall not exceed 75% of combined tuition cost, and room and board cost, if applicable.

The school to be attended must include at least one CALLERLAB Accredited Caller-Coach on the staff and the school must offer the full 40 hour CALLERLAB Caller School Curriculum.

Applicants must complete the enclosed application form in its present or later amended form. Applications will be accepted at the CALLERLAB Home Office until May 1<sup>st</sup> of each award year. All applications received by May 1<sup>st</sup> will be considered by the CALLERLAB Foundation Executive Directors (FED). Applications received after May 1<sup>st</sup> may not be considered.

Each applicant must submit a written essay. This essay must include: 1) brief history of dancing & calling experience, 2) history of past caller training, including list of schools, 3) statement of need: 4) and a statement of intention. Those callers who have been calling less than five years and have not yet attended a caller school shall be given priority in the selection process.

No single individual shall receive more than one scholarship award from this fund. No husband/wife or other "team" shall receive more than one scholarship award from this Fund, considered jointly or severally. Approval of an application by a caller or "team" who has received another scholarship through CALLERLAB or the CALLERLAB Foundation will not normally be approved except for exceptional circumstances as determined by the FED.

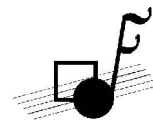
