### FROM THE CHAIR By Barry Clasper, Chairman

In my last article, I offered what I hoped were some provocative ideas that would spark discussion. Apparently you're not easily provoked. Either that or the notions of competition and testing as ele-

ments of square dancing are not as "out there" as I surmised.

I received a handful of personal replies, all expressing general agreement and interest in the ideas. I saw a couple of notes in discussion lists expressing disagreement not so much with my specific thoughts as with the whole idea of even discussing competition in square dancing. But, all in all, I didn't exactly generate a flurry of comment. I could choose to interpret that as a measure of general public apathy in the subject, but I'm instead going to construe it as a silent majority waiting to hear more; ever the optimist.

The last article focused mostly on the role competition might play in improving square dancing. This time I'm going to talk about the idea of testing. Competition is, of course, a type of testing. Competitors test their skills against one another. Testing, on the other hand, involves measuring skills against some sort of objective standard.

Many recreational activities incorporate the idea of testing. Sometimes it's just a way to measure a level of activity or document accomplishment. For example, bird watchers keep logs of their sightings (which can be used as credentials in competitions) and enjoy comparing them. For others, it's necessary to ensure safety: scuba diving and sky diving demand certain levels of skill to be done safely. Or, it can be to measure or document an individual's progress through a hierarchy of skills. Several forms of dance fall into that last category. Ballet, ballroom, jazz, and tap, for example, have associated "medal examinations" that measure proficiency and award medals based on degrees of mastery. (continued on page 2)

Of course, medal examinations are undertaken only by the truly serious, not casual participants. Indeed, with the exception of activities with safety requirements, most recreations have a "casual" level of practice allowing people to participate without passing any tests. Ostensibly, for MWSD that would be the "big tent" offerings I have mentioned in past articles; the Community Dance Program, ABC dances, and the like. In order to walk into a Basic dance (not that there are bunches of them around) someone would have had to go through a set of lessons, or some equivalent. The vast majority of people in MWSD exclusively dance programs beyond Basic, which I contend demand a skillset well beyond "casual". And they mostly got there without ever having to demonstrate competence in any formal way.

"Wait", you say. "All those dancers took classes!" Too true. And what exactly did they have to demonstrate to "graduate" from the class? For the most part, all they need is a receipt showing fees paid in full. Some places are a little more stringent and have an attendance requirement as well. But very seldom is a student told they lack the skills to graduate and need further training. We used to be more brutal about this in the "old days", but in our current age of enlightenment we feel it's wrong to "fail" people at just about anything. It's better to send them off into the world, blissfully unprepared, to fend for themselves. This is not an act of kindness, neither to the students themselves or to the squares they join.

Cognitive scientists have documented something called the "Dunning-Kruger Effect". It describes a cognitive bias causing individuals with the lowest skill levels to overestimate their skills, while those with the highest skill levels underestimate their skill. It has also been described as "the inability of the unskilled to recognize their ineptitude". Square dancing offers fertile ground for this phenomenon since failure can be blamed on eight other people (seven dancers and the caller). I'm sure you can all readily bring examples to mind. Since we do not test, it can be very hard to disabuse someone of the notion that they're doing just fine.

In the past we were more willing to demand, at least in an informal way, a certain standard of performance from dancers "graduating" from a set of lessons. The erosion of that willingness has resulted in the standard of execution on floors for all programs becoming highly variable. The standard of dance at Plus Club A can be radically different to that at Plus Club B down the road. More importantly, on any given floor the skill gap between the most competent and least competent dancers has grown into a chasm. It is becoming increasingly difficult to call a dance that will be enjoyed by all dancers on the floor. Ideally, we want that gap to be small enough that by calling to the median skillset we provide a dance that slightly stretches the less skilled yet still provides the more skilled with an interesting and enjoyable dance. These days that strategy usually causes the less skilled to be bludgeoned and the more skilled to be bored. Testing is a way to start narrowing that gap again.

Let's assume that you're now all on board with this testing idea (HUGE assumption, I know). I'm visualizing these tests as something a dancer considering moving on to the next program would take to demonstrate they have the foundation for the new material. Given our current suite of programs that would imply the first test dancers would see is before enrolling in Mainstream lessons (i.e., after completing Basic).

What would that testing look like? Good question! Answering it requires us to examine a lot of subquestions, such as: How do you administer the test? How do you measure performance? What is required to pass? What does the grading system look like, etc.? Missing from that list is the very first question—one that will generate as much discussion and indecision as has figuring out what calls should be in the entry program: What skills need to be tested?

Well, here's a few that occur to me (as I implied, I'm sure there will be lots of diverging opinion let's hear it).

- The ability to step to the beat of the music and take the appropriate number of steps to execute calls.
- The ability to move smoothly and use properly measured hand pressures and grips.
- The ability to recognize formations and their position within them.
- The ability to maintain appropriately sized formations.
- Call knowledge, including the ability to dance reflexively fundamental calls such as circulates, trades, runs, and casts.

- The ability to react to properly timed calls at dance speed.
- The ability to finish calls in their proper place in the new formation, and facing the correct direction.
- The ability to process a new call without stopping after finishing the preceding call.
- The ability to recover from mistakes.

Once we have a consensus on a list of what skills should be tested, we can begin to work on the subsequent questions such as how we might assess these attributes in a given dancer. But that's for later. For now, what dance skills should we test? What makes a good Basic dancer? Mainstream dancer? Plus dancer?

The CALLERLAB Foundation operates through private contributions, public grants, and endowments. Goals and objectives can be met only if funds are made available. In order to ensure that the American folk art of square dancing will continue to flourish, the CALLERLAB Foundation needs your support through your contributions.
