This 'FLASH' issue of *DIRECTION* is published as soon as possible after the Annual Convention in order to inform all CALLERLAB Members of significant actions taken at the Annual Meeting. This issue includes the results of any voting during the 2019 Annual Meeting of the Members, information about award presentations, and reports from certain committees. Additional committee reports are included with the minutes of the 2019 Annual Meeting.

**RESULTS OF
CONVENTION VOTE**

The 2019 CALLERLAB Call to Convention, published in the January/February 2019 issue of *DIRECTION*, informed all Members that two proposed resolutions which required action by the Membership had been submitted and would be presented at the 2019 Annual Membership Meeting. The resolutions were presented to the Membership during the 2019 Annual Meeting on Wednesday, April 17, 2019. The first resolution was approved by the Membership at the meeting as presented.

The second resolution was discussed. An amendment was approved and the amended Motion was approved by the Membership at the meeting.

The resolutions will be submitted to all voting Members by U. S. mail for vote.

The first resolution reads as follows:

Resolution to Change the Name of the Mainstream Committee to the Basic and Mainstream Committee.

Whereas: The oversight of the CALLERLAB Basic and Mainstream program lists is the charge of the

Mainstream Committee; and

Whereas: The Mainstream Committee voted to separate the Basic and Mainstream Program lists and number them separately; and

Whereas: Other program committees oversee multiple programs (Challenge, for instance, oversees three programs);

Whereas: The Basic List provides the fundamentals upon which the rest of Modern Western Square Dancing is based, and this should be clearly recognized and honored by including it in the committee title; and

Whereas: It is in the best interest of Modern Western Square Dancing for one committee to oversee both the Basic and Mainstream Programs.

Therefore: Be It Resolved That; Paragraph 6 of the Board Of Governors’ Program Policy be amended to change the name of the “Mainstream Committee” to “Basic and Mainstream Committee”. The remainder of the Program Policy remains unchanged.

The second resolution reads as follows::

Part 1

Whereas: The current CALLERLAB Bylaws were written before electronic means of addressing business were as common as they are today, and

Whereas: It is within the legal guidelines of the CALIFORNIA NONPROFIT MUTUAL BENEFIT CORPORATION Codes covering CALLERLAB to include e-mail and other electronic approaches as a means of balloting outside of meetings; and

Whereas: The current Bylaws, Article III, MEETINGS OF MEMBERS, Section 6. Action by mail is not written to include voting by e-mail, or other electronic means; and

Whereas: It is the commitment of this organization to ensure that all Members are enfranchised

and have a viable, accessible, and easy means of balloting that supports this commitment; and

Whereas: In order to support such a change in the balloting process, an amendment of Article III, MEETINGS OF THE MEMBERS, Section 6. Action By Mail of the Bylaws is required.

Therefore, let it be resolved that: Article III. MEETINGS OF THE MEMBERS. Section 6, Action By Mail of the CALLERLAB Bylaws, be amended to read:

III. MEETINGS OF MEMBERS

Section 6. Action by Mail. **ACTION OUTSIDE OF MEETINGS.** Except as provided by law or required by these Bylaws, any action that may be taken at a meeting of the Members may be taken by written ballot, provided that a ballot is sent to every Voting Member **via the means specified by the Member and as recorded in the corporate records**, and at least 15 days is allowed for responses. The quorum for a mail ballot **outside of meetings** shall be one-third (1/3) of the number of ballots issued. No written ballot shall be accompanied by any argument or recommendation of a specific result, unless it carries an argument for each side written by an advocate of that side.

Whereas: The current Bylaws, Article IV. BOARD OF GOVERNORS, Section 4. Election. is not written to include voting by e-mail, or other

Whereas: It is the commitment of this organization to ensure that all Members are enfranchised and have a viable, accessible and easy means of balloting that supports this commitment; and

Whereas: In order to implement such a change in the balloting process, an amendment of Article IV, BOARD OF GOVERNORS, Section 4. Election. of the Bylaws is required.

Therefore Be It Resolved That: The CALLERLAB Bylaws, Article IV, Board of Governors, Section 4. Election, be amended to read as follows:

ARTICLE IV: BOARD OF GOVERNORS

Section 4. Election. The Governors shall be elected by written ballot or, if such a vote is not conducted or is for any reason found invalid, then by the Members at the Annual Meeting of the Members or any special meeting held in lieu thereof, **ballots that are distributed to qualified Voting Members via the means, electronic or by mail, designated by the Member and as recorded in the corporate records.**

Ballots must be returned by the date specified in accordance with Section D below to be considered valid. Each qualified Voting Member shall submit only one ballot.

If such a vote is not conducted, or is for any reason found invalid, then **Governors will be elected by ballots issued to the Voting Members** at the **next** Annual Meeting of the Members or any special meeting held in lieu thereof.

The election procedure shall be as follows:

(A) The corporation shall, by June 15 of each year, send written notice to each Voting Member **in Good Standing, via the means specified by the Member and as recorded in the corporate records. This notification shall inform each Voting Member** that nominations are in order for the class of the Board of Governors whose term is to expire at the next Annual Meeting, and for such other governorships that are vacant or required to be filled by election. Any Active Member in good standing may nominate any eligible Voting Member, including himself/herself.

(B) Each submitted nomination shall have thereon or attached thereto, in addition to the signature of

the nominator, the signatures of at least twenty-five (25) Voting Members who concur in the nomination. To be valid, a nomination must be in the hands of the Executive Director no later than July 1. **[NOTE: There are no proposed changes to Subsection (B).]**

(C) After the qualifications of the nominators, nominees, and supporting signatories have been verified as being in accordance with this Article, the names of the nominees who have been properly nominated shall be placed on ballots and a ballot shall be sent to each Voting Member **via the means specified by the Member and as recorded in the corporate records** no later than August 15.

(D) Each Voting Member may cast one vote for each Governorship to be filled. However, no Member may cumulate his votes, nor vote for more than the number of Governorships to be filled. All ballots shall be returned to the Executive Director of the corporation no later than 45 days after the mailing of ballots. **Ballots must be returned by the established closing date for that election by mail, fax, or e-mail, and have a postmark or electronic mail time of before midnight on that date.**

[NOTE: There are no proposed changes to the remainder of ARTICLE IV, BOARD OF GOVERNORS, Section 4. Election.]

Part 3

Whereas: The Board of Governors (BOG) is the CALLERLAB leadership and policy making body, and as such are considered the Directors of the corporation, and

Whereas: The current CALLERLAB Bylaws were written before electronic means of addressing business were as common as they are today, and

Whereas: It is the commitment of this organization to ensure that all Members are enfranchised and have a viable, accessible and easy means of balloting that supports this commitment, and

Whereas: Members of the Board of Governors are democratically elected by the membership-at-large and are entrusted by the membership to make and oversee the policies of the organization. Due to the fact that they make and set policy, they must have well announced, formal face-to-face

meetings; and

Whereas: As a California Nonprofit Mutual Benefit Corporation, the Board of Governors, may conduct electronic meetings where they deliberate and vote on CALLERLAB policy issues when these meetings are appropriately called and constructed. Electronic meetings include participation through use of conference telephone, electronic video screen communication, or electronic transmission by and to the corporation.

Whereas: In order to implement such a change in the balloting process, an amendment of Article V, MEETINGS OF THE BOARD, of the Bylaws is required.

Therefore, let it be resolved that: Article V, MEETINGS OF THE BOARD, of the Bylaws of CALLERLAB be amended to read as follows:

ARTICLE V. MEETINGS OF THE BOARD

[New Section] Section 6. Electronic Meetings.

As a California Nonprofit Mutual Benefit Corporation the Board of Governors may conduct electronic meetings where they deliberate and vote on CALLERLAB issues when these meetings are properly called and constructed. Electronic meetings of the Board must adhere to the policy, procedures, and guidance contained in the Board of Governors document titled "Procedures For Electronic Meetings of the Board of Governors."

[New Section] Section 7. E-mail Discussion and Voting.

E-mail discussion and voting is allowable under California Code if it is well documented that all Members were aware of and had ample opportunity to participate in electronic discussion, and 100% of the Directors have provided written consent as described below.

Each Board Member is annually required to sign a statement acknowledging that electronic mail will be used for discussions and voting on items submitted to the Board outside of the annual face-to-face meeting, and that they have the means and ability to participate in electronic discussions. The Home Office will maintain a record of each Board

Member's written consent for the current year.

The Board of Governors may choose to allow its members to informally discuss issues via e-mail. These discussions must be conducted with clear provision to ensure that all members are aware of them and involved in them. At the conclusion of such discussion, an electronic straw poll may be taken, but final votes need to be confirmed at a face-to-face or appropriately set up electronic meeting of the Board of Governors, or using the process described in the next paragraph.

E-mail voting on a proposal circulated and responded to by e-mail is essentially a proxy vote without verbal face-to-face debate. In order for this form of voting to meet the California Code, it must be followed by unanimous written consent from all the Directors that the action taken via the e-mail vote would have been taken if a meeting had been held. The only exception to the unanimous written consent is in the case of a conflict of interest in which one or more Directors have to excuse themselves from the vote.

**CHAIRMAN'S SPEECH
PRESENTED AT THE
46THCALLERLAB
CONVENTION

Hello Rockstars! I didn't anticipate how difficult this speech would be to write. This will be my last time to stand before you as your Chairman and share what is on my heart and mind.

My good friend, Tony, was right when he described how very difficult it is to stand before you and TALK to you. Since finding my corner right now would be more than a bit stressful, can I just skip out and do a couple of singing calls and call it a

night? THAT would be super easy! Yes? Well, never being one to take the easy road, I probably shouldn't squander this moment. So here is version 234.89 of this speech.

I thought that Tony kicked off this Convention with a super keynote speech. Were you listening? Do you remember any of his "ATE" words? They are words that each of us should remember and take to heart as we continue to Rockstar our groups and make a difference in this beloved activity. Just in case you didn't write them all down, let me refresherate your memory (if he can make up words, so can I!). In addition to a mind-bending list of circulates and other "ATE" call names, a couple of not-so-tongue-in-cheek new calls he'd like to invent, he talked about the following:

Accommodate; Appreciate; Celebrate; Dedicate; Demonstrate; Educate; Elevate; Articulate; Illuminate; Passionate; Considerate; Consummate (professional!); Create; Innovate; Relate; Illuminate; Cooperate.

Let me reiterate them again: Accommodate; Appreciate; Celebrate; Dedicate; Demonstrate; Educate; Elevate; Articulate; Illuminate; Passionate; Considerate; Consummate (professional!); Create; Innovate; Relate; Illuminate; Cooperate.

Steve will tell you that I am a rainbows and unicorn type of girl. Let me digress and say that without Steve, I never would be able to do what I do. He has sacrificed a lot, and has patiently put up with my hair brained ideas, my absences, my distractions, dancing when he didn't want to, being a sounding board, and cheerleading me. Thanks, babe, for being a good sport. And as a reminder to all of you: your partners, be they husband, wife, family, friend, dog, cat, are as important as the people that come to your dances.

Back to my rainbow and unicorn world. I choose to believe in the good. Even though we have some big and small issues and some things to work out between ourselves, our dancers, and our non-dancing public, I refuse to buy into the doom and gloom that seems to be much easier to pontificate on. Instead, I am encouraged by what I have seen and heard the past two years. The naysayers can moan and complain and boo hoo as much as they want. I choose to believe that there is still good in

this activity. A LOT of good, actually.

I am encouraged by the addition of Teresa as our Assistant Executive Director. I am proud that I was able to have a small hand in getting this position in place and filling the role. We are stepping out in faith and making an investment in the future of our organization and our activity. That is something to celebrate!

I am encouraged by the membership report the Board of Governors got during our meeting on Sunday. You all heard the VERY long list of callers we have lost in the past year. I head many of you talking about that list. Yet, while this was a difficult year of losses, we had a net gain of one Member. "So what," you might say—we didn't grow very much." Yup. True. **But we had a net gain of one; we defied our own projection of loss!** That means that in the big scheme of things, we DO have new callers coming up. I think that is cause to celebrate! So which of the "ATE" words can you use to help our newer callers to keep on keeping on? How about Demonstrate, Articulate, Relate, Cooperate, Educate? What about Cultivate (support them and give them opportunities)? Or how about Irrigate (water them frequently with encouragement)?

I am encouraged by the response that the Marketing Report is receiving. There are many callers and dancers/clubs that are starting to use the tools in that document. And even lots who are **thinking** about the items presented. "So what?" some of you say. "Our bottom line hasn't changed." But people are rethinking how they might better market, and they are sticking their toes in the water with regards to the tools out there in this century that might help. And there have been pockets of success all over. Pockets of success, as far as I am concerned, are reason to Celebrate, Emulate, Appreciate, Relate, and Copycateate!

I am over the moon encouraged by some of the conversations I have overheard as I wandered around the Convention. I hear a tangible shift in the tone and content: you are having real conversations with people; you are making connections; you are treating each other with respect; and you are welcoming those who are not like you. And THAT checks off a LOT of "ATE" words!

I am encouraged by the subtle shift in your EC, BOG, and committees from a place of “maybe someday” to action. Action is the only way to move from inertia to forward movement. The definitions project is almost complete, policies and workflows are being actively reviewed and streamlined, updated, and sometimes reworked, and we’ve got a few projects that have happened in (for us!) an efficiently short timeframe. Lots of “ATE” words there. One that is increasingly going **away** is stalemate—our Members are compromising, talking with each other, and acting on decisions.

But the one thing that I am most encouraged about, is that in addition to our constant discussions about choreo, marketing, and the other mechanics of our activity, we are actively talking about the personal side—sociability. I’ve been talking about it for years. Your Past Chairs, EC, and Board are actively working on how to innovate, motivate, and educate the lost art of sociability.

Throughout my teens and into my early 20s I was involved with a summer camp in New Hampshire—the Deering Conference Center. I started out in 5th grade as a camper, was on staff as a counselor, then worked summers on Camp Family, and cooked and cleaned and maintained the property; I was the camper that wouldn’t leave. The couple that was in charge of the camp are like a second father and mother—to me and everyone else that passed through. When Gordon passed away a couple of years ago, my Deering family came together and shared stories about the things we remember: the memories of singing at the top of our lungs or weeping or worshipping together; doing dishes and eating together. Those moments that we created are still strong and meaningful. Some of these people I haven’t seen in over 35 years; some I communicate with on a regular basis. The one thing that we keep coming back to is that strong bond of community even after all these years that still ties us together as family and friends. I always wear or have in my pocket a cross that each of us at Camp Family received. It reminds me that I am connected and have a family even in the midst of the chaos of my life. My Deering family recognizes that in spite of our diverse backgrounds and beliefs, in today’s

world this connectivity is something to take to the bank.

This feeling of community is what I feel today with my square dance family. We laugh uncontrollably, we ache and cry for each other, we celebrate milestones and victories, we work together in groups of eight to problem solve, we drive literally hours to spend a couple of hours with our favorite people; I stay up way too late having conversations with people on the other side of the world.

I still maintain that people in today’s world could use some face-to-face community time with other people. We all spend so much time isolated these days between schlepping kids and grandkids around, working two to three jobs, taking care of our homes or family members. Square dancing can offer a place to come and be accepted, dance and work together, fellowship, laugh, support each other, break bread together. Me and my rainbow and unicorn world is convinced that if we can find a way to get that piece back in our groups, it could go a long way in turning the tide around.

That missing piece is the sociability factor. It’s something that should be cultivated and celebrated and modeled regardless of the level or type of group. It applies to community dances, to Mainstream, all the way up to Challenge. It applies across the board to our national, regional, local organizations and events. It might look differently depending upon who you are, but I strongly believe that is the common glue that binds.

I hope that as we begin to dialogue and educate about sociability that you will listen, participate, and contribute. I hope that you, as leaders and Rockstars of the activity, will re-interject this piece of the puzzle into your groups. And I hope that you are comfortable enough to share back with us what you are doing, what is working, and how you are doing it. We, your family, are aching for these stories to be shared.

Boy. What a ride it’s been! I am humbled and

honored that I have had the opportunity to serve the organization as your chairman. You will never know the depth of my thankfulness for your support and tolerance. While I might have allowed myself to have a teensy little dream about standing here, I didn't think in a million years that it would ever happen. The path has been rocky and full of beautiful vistas and unexpected landmines. But, here I stand before you. Anything is possible. Don't stop dreaming big and shooting for the stars though the road may be rough and rocky. I don't care where you are on the rung of your calling career. The only thing that will hold you back is your unwillingness to dream big. Believe in yourself. Walk your path with integrity. Say no when you need to, and yes when you can. Never stop working and striving to become a better version of YOU; beautiful, handsome, talented quirky wonderful YOU. We so desperately need what only you can bring to this table. One final thought:

He brings gifts into our lives, much the same way that fruit appears in an orchard—things like affection for others, exuberance about life, serenity. We develop a willingness to stick with things, a sense of compassion in the heart, and a conviction that a basic holiness permeates things and people. We find ourselves involved in loyal commitments, not needing to force our way in life, able to marshal and direct our energies wisely. You are all still, and always will be, my Rockstars for sure. I'll see you on the flip-side! Will you join me?

Our Award Recipient tonight began calling in 1962 and joined CALLERLAB in 2004. He attended his first Convention in 2005, and this is his 14th Convention.

He has served as Vice Chairman of the Plus Committee since the fall of 2016 and has actively served on all of the following committees: the Advanced Committee; Choreographic Applications Committee; International Advisory Committee; Mainstream Committee; Marketing Committee; Public Relations Committee; and the following Ad Hoc Committees: Mainstream Abridge Definitions and Mainstream Teaching Order.

When I say “actively served”, I mean he responds and participates more than almost any other Committee member. His responses often lead most of the discussion.

He has served as a panelist at many of CALLERLAB’s Conventions and has been a very important liaison between CALLERLAB and the All Japan Square Dance Association.

As many of you know, the All Japan Square Dance Association is made up of callers, cuers, dancer leaders, and dancers, and he has been a strong proponent of that concept for square dance growth and success.

The Executive Committee selected him for this Award because of his many contributions to CALLERLAB, and as a valuable liaison to all of Japan.





2018 PLUS TRIENNIAL REVIEW

The current CALLERLAB Program Policy requires a review of all CALLERLAB dance programs at least once every three years. This review is conducted by each applicable dance program committee and is known as the “Triennial Program Review.” This review is conducted as follows: first the Mainstream Committee completes its review of the Basic & Mainstream Programs, then the Plus Committee conducts its review of the Plus Program, then the Advanced Committee conducts its review, and finally the Challenge Committee conducts its review. During these reviews each program committee will review the applicable dance program to determine if any changes are required. Changes can include additions or removal of calls from the program.

The Mainstream Committee results were published in the September/October 2018 DIRECTION.

The Plus Committee made no changes to the Plus Program.

The Advanced Committee made no changes to the Advanced Program.

The Challenge Committee results are shown below:

C-1 Program:

- Add — TRACK N (0, 1, 2, 3, 4)
- Add — PASS & ROLL YOUR CROSS NEIGHBOR

C-2 Program:

- Add — GRAND DROP
- Add — PASS AND ROLL YOUR CRISS CROSS NEIGHBOR
- Add — ANY TAGGING CALL YOUR CROSS/CRISS CROSS NEIGHBOR

C - 3 Program:

- Add — SINGLE SHAKEDOWN/SINGLE TURN AND DEAL
- Add — ADD INTERLOCKED EXTEND
- Add — HINGE THE TOP TO LOCK THE HINGE FAMILY
